HEALTH IN HARMONY ENGAGES COMMUNITY-LED SOLUTIONS FOR HUMAN HEALTH AND THE HEALTH OF OUR PLANET. FOR MORE THAN A DECADE, WE HAVE WORKED WITH OUR INDONESIAN PARTNER, ALAM SEHAT LESTARI (ASRI) TO ASK COMMUNITIES WHAT THEY WOULD NEED TO STOP LOGGING IN GUNUNG PALUNG NATIONAL PARK ON THE ISLAND OF BORNEO AND THEN IMPLEMENT THEIR IDEAS. FOR THESE COMMUNITIES, PROTECTING THE RAIN FOREST HAS MEANT RUNNING A HEALTH CARE CLINIC WITH ALTERNATIVE PAYMENT OPTIONS AND DISCOUNTS FOR REDUCING LOGGING, TRAINING IN ENTREPRENEURSHIP, AND SUSTAINABLE LIVELIHOODS, CONSERVATION OF THE PARK, AND ADULT AND CHILD EDUCATION. THESE PROGRAMS NOT ONLY PROTECT AND RESTORE CRITICAL ORANGUTAN HABITAT AND CARBON STORES, BUT LEAD TO IMPROVED HEALTH OUTCOMES, INCREASED ECONOMIC SECURITY, GREATER EDUCATIONAL ACHIEVEMENT, AND WOMEN'S EMPOWERMENT. ASRI IS LOCALLY OWNED AND OPERATED, AND THE COMMUNITIES ARE AT THE CORE OF ALL DECISION-MAKING. IN ADDITION, WE CONDUCT RIGOROUS MONITORING AND EVALUATION, USING DATA AND COMMUNITY FEEDBACK TO CONSTANTLY REFINE PROGRAMMING AND DEFINE OUR THEORY OF CHANGE METHODOLOGY, SO WE CAN PREDICATE AND ULTIMATELY SCALE THIS MODEL. HEALTH IN HARMONY'S FOCUS, IN ADDITION TO SUPPORTING ASRI WITH FUNDING AND PARTNERSHIP DEVELOPMENT, IS TO ACTIVELY RESEARCH NEW SITES IN INDONESIA AND AROUND THE WORLD, TO AGAIN CONDUCT COMMUNITY MEETINGS AND IDENTIFY COMMUNITY-LED SOLUTIONS FOR CONSERVATION AND IMPROVED HUMAN WELLBEING IN OTHER CRITICAL ECOSYSTEMS.

ECOSYSTEM IS THE ROUGHLY 267,000-ACRE GUNUNG PALUNG NATIONAL PARK, A TROPICAL RAIN FOREST AND HABITAT FOR 2,500 ENDANGERED ORANGUTANS. THE COMMUNITIES ASKED ASRI FOR AFFORDABLE HEALTH CARE AND TRAINING IN SUSTAINABLE LIVELIHOODS. TODAY, HEALTH IN HARMONY PROVIDES THE MAJORITY OF THE OPERATING FUNDS, AS WELL AS TECHNICAL SUPPORT FOR ASRI TO RUN A HEALTH CARE CLINIC WITH INPATIENT, OUTPATIENT, DENTISTRY, MIDWIFERY, AND PHARMACY SERVICES. THE CLINIC IS STAFFED BY YOUNG INDONESIAN PHYSICIANS TRAINED BY A ROTATING COHORT OF VISITING PHYSICIANS AND SENIOR INDONESIAN PHYSICIANS. IT ACCEPTS NON-CASH PAYMENTS (SUCH AS SEEDLINGS) AND PROVIDES DISCOUNTS FOR PATIENTS FROM VILLAGES THAT HAVE REDUCED OR ELIMINATED LOGGING. IN ADDITION, WE SUPPORT ASRI'S TRAININGS IN SUSTAINABLE AGRICULTURE AND FOSTERING OF FARMERS' COOPERATIVES, SMALL BUSINESS LOANS AND ENTREPRENEURSHIP TRAINING, TWO REFORESTATION SITES, AND OTHER LIVELIHOOD PROGRAMMING FOR MEN AND WOMEN IN THE REGENCY AROUND THE CLINIC.

IN 2018, IN PARTNERSHIP WITH ASRI, WE EXPANDED SERVICES TO ANOTHER NATIONAL PARK IN WEST KALIMANTAN, BUKIT BAKA BUKIT RAYA. THE COMMUNITIES AROUND THIS 514,000-ACRE NATIONAL PARK FACE SIMILAR CHALLENGES TO LIVING IN HARMONY WITH THEIR ENVIRONMENT AS THE COMMUNITIES AROUND GUNUNG PALUNG, INCLUDING SIGNIFICANT MATERNAL MORTALITY. THESE HEALTH EMERGENCIES AND RESULTING HIGH MEDICAL BILLS FORCED COMMUNITIES TO LOG TO PAY FOR BASIC NEEDS AS A WAY OF LIFE, DESTROYING THEIR NATURAL RESOURCES AND HABITAT FOR A GROWING REHABILITATED ORANGUTAN POPULATION. WE HAVE STATIONED TWO MIDWIVES IN THESE COMMUNITIES AND CONDUCTED MORE THAN 400 PATIENT VISITS IN 2018.

WE ARE FURTHER EXPLORING REPLICATION OF OUR MODEL AT SITES OUTSIDE OF INDONESIA AS WELL AS MECHANISMS TO RAPIDLY SCALE OUR APPROACH IN ORDER TO PROTECT AS MANY ECOSYSTEMS ALONGSIDE AS MANY COMMUNITIES AS POSSIBLE.

IN ADDITION TO INDIVIDUAL STUDENTS OF ALL AGES, WE PARTNER WITH UNIVERSITIES AROUND THE WORLD TO HOST FIELD COURSES AT ASRI FOR UNIVERSITY STUDENTS AND ALSO OFFER TRAINING IN RADICAL LISTENING METHODOLOGY FOR NON-PROFITS, CORPORATIONS, AND INDIVIDUALS WHO CAN APPLY THESE EFFECTIVE PRINCIPLES TO THEIR WORK.
